TRAFFICKING IN METHAMPHETAMINE (CONSPIRACY)
S.C. Code Ann. § 44-53-375(C)(5)**

That ALEX LNU, A/K/A "FATMAN", DAVID MARTINEZ, A/K/A "MIGO", DARRELL FOSTER MCCOY, JR., A/K/A "DJ", MATTHEW DAVID MCCOY, WESLEY SCOTT WRIGHT, MISTIE DAWN BLACK, JOHN LUTHER CODY MURPHY, WANDA DIANE WRIGHT, LAUREN ASHLEY KUYKENDALL, BENNY ALEXANDER, A/K/A "LIL B", MICHAEL DUAIN PAYNE, A/K/A "MIKE MIKE", DOUGLAS RHODES, A/K/A "DOUGIE", TONY EUGENE MCCOY, MARIA SUMMER CROMER, JESSICA CHANDLER CROMER, TIMOTHY BRYAN CARTEE, A/K/A "SUPERMAN", WARREN CHASTAIN, REGINA GAMBREL, A/K/A "DIRTY", CHARLES CALDWELL, JR., A/K/A "BUB", COREY DALTON CRUMP, TOMMY WATERS A/K/A "TOMMY GUN", JOHNNY BANKS, JESSICA VELEZ BOLEMAN, MICHAEL PERINO PARDI, A/K/A "PAUL WALL", and other persons whose names are both known and unknown to the State Grand Jury, did in Anderson, Greenville, and Pickens counties of South Carolina, from January 1, 2011 until June

18, 2013, knowingly conspire with each other to sell, manufacture, deliver, purchase, or bring into this State or provide financial assistance to sell, manufacture, deliver, or purchase four hundred (400) grams or more of methamphetamine ("ice" or "crank"), a controlled substance under the provisions of § 44-53-110, *et. seq.*, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such activity occurring and/or having significance in more than one county of this State or arising out of or in connection with a crime having significance in more than one county of this State.

COUNT TWO
TRAFFICKING METHAMPHETAMINE 28-100 GRAMS
S.C. Code Ann. § 44-53-375(C)(2)(a)

That DARRELL FOSTER MCCOY, JR., A/K/A "DJ" and MISTIE DAWN BLACK did, in Greenville County, South Carolina, on or about August 28, 2012, knowingly possess (actually or constructively), deliver, sell, or bring into this State, twenty-eight (28) grams or more but less than one hundred (100) grams of methamphetamine ("ice" or "crank"), a controlled substance under the provisions of § 44-53-110, *et. seq.*, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such activity occurring and/or having significance in more than one county of this State or arising out of or in connection with a crime having significance in more than one county of this State.

COUNT THREE
POSSESSION OF METHAMPHETAMINE
S.C. Code Ann. § 44-53-375(A)

That TIMOTHY BRYAN CARTEE, A/K/A "SUPERMAN", did, in Greenville County, South Carolina, on or about August 28, 2012, knowingly possess (actually or constructively) a quantity of methamphetamine ("ice" or "crank"), a controlled substance under the provisions of § 44-53-110, *et. seq.*, Code of Laws of South Carolina (1976), as amended, such conduct not

having been authorized by law and such activity occurring and/or having significance in more than one county of this State or arising out of or in connection with a crime having significance in more than one county of this State.

POSSESSION OF A FIREARM DURING THE COMMISSION
OF A VIOLENT CRIME
S.C. Code Ann. § 16-23-490**

That DARRELL FOSTER MCCOY, JR., A/K/A "DJ" did, in Greenville County, South Carolina, on or about August 28, 2012, possess or visibly display a firearm, described as a Cobra .32 caliber semi-automatic pistol S/N FS0375-48 and a Beretta .32 caliber semi-automatic pistol S/N A20479 during the commission of a violent crime, to-wit, Trafficking in Methamphetamine, such conduct not having been authorized by law and such activity occurring and/or having significance in more than one county of this State or arising out of or in connection with a crime having significance in more than one county of this State.

**COUNT FIVE
POSSESSION OF A FIREARM DURING THE COMMISSION
OF A VIOLENT CRIME
S.C. Code Ann. § 16-23-490**

That MISTIE DAWN BLACK did, in Greenville County, South Carolina, on or about August 28, 2012, possess or visibly display a firearm, described as a Cobra .32 caliber semi-automatic pistol S/N FS0375-48 and a Beretta .32 caliber semi-automatic pistol S/N A20479 during the commission of a violent crime, to-wit, Trafficking in Methamphetamine, such conduct not having been authorized by law and such activity occurring and/or having significance in more than one county of this State or arising out of or in connection with a crime having significance in more than one county of this State.

COUNT SIX
POSSESSION OF A FIREARM BY PERSON CONVICTED OF A CRIME OF
VIOLENCE
S.C. Code Ann. § 16-23-30

That DARRELL FOSTER MCCOY, JR., A/K/A "DJ" in Greenville County, South Carolina, on August 28, 2012, willfully and unlawfully possess a firearm, described as a Cobra .32 caliber semi-automatic pistol S/N FS0375-48 and a Beretta .32 caliber semi-automatic pistol S/N A20479 he having been convicted of a crime of violence in the Courts of the State of South Carolina, he not being authorized by law to possess a firearm, in violation of S.C. Code Ann. § 16-23-30 Code of Laws of South Carolina (1976), as amended such conduct not having been authorized by law and such activity occurring and/or having significance in more than one county of this State or arising out of or in connection with a crime having significance in more than one county of this State.

EXPOSING A CHILD TO METHAMPHETAMINE

EXPOSING A CHILD TO METHAMPHETAMINE

That MISTIE DAWN BLACK did, in Greenville County, South Carolina, on or about August 28, 2012, knowingly permit a child to be in an environment where a person was selling, offering for sale, or having in such a person's possession with intent to sell, deliver, distribute, prescribe, administer, dispense, manufacture, or attempt to manufacture methamphetamine, a controlled substance under provisions of § 44-53-110, et seq., Code of Laws South Carolina (1976, as amended), such conduct not having been authorized by law and such activity occurring and/or having significance in more than one county of this State or arising out of or in connection with a crime having significance in more than one county of this State.
