All in violation of § 44-53-475 of the South Carolina Code of Laws (1976), as amended, such conduct not having been authorized by law; such conduct having significance in more than one county of this State; and such conduct arising out of and in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

All in violation of § 44-53-475 of the South Carolina Code of Laws (1976), as amended, such conduct not having been authorized by law; such conduct having significance in more than one county of this State; and such conduct arising out of and in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

COUNT SEVEN
POSSESSION WITH INTENT TO DISTRIBUTE MARIJUANA
S.C. Code Ann. § 44-53-370(b)(2)

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about May 19, 2017, knowingly possess with intent to manufacture, distribute, dispense, or deliver a quantity of marijuana, a controlled substance under the provisions of § 44-53-110, *et seq.*, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law; such conduct having significance in more than one county of this State; and such conduct arising out of and in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

### COUNT EIGHT POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME S.C. Code Ann. § 16-23-490

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about May 19, 2017, possess or visibly display a firearm during the commission of or attempt to commit a violent crime to wit: the defendant did possess a .223 caliber American Tactical Imports Omni assault rifle, bearing serial number 31024, during the commission of and in furtherance of a cocaine trafficking conspiracy, a heroin trafficking conspiracy, and a marijuana trafficking conspiracy, in violation of § 16-23-490, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such conduct arising out of or in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

## COUNT NINE POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME S.C. Code Ann. § 16-23-490

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about Page 8 of 12

May 19, 2017, possess or visibly display a firearm during the commission of or attempt to commit a violent crime to wit: the defendant did possess a CZ Scorpion EVO 3S1 9mm sub-machine gun pistol, bearing serial number CO58171, during the commission of and in furtherance of a cocaine trafficking conspiracy, a heroin trafficking conspiracy, and a marijuana trafficking conspiracy, in violation of § 16-23-490, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such conduct arising out of or in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

## COUNT TEN POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME S.C. Code Ann. § 16-23-490

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about May 19, 2017, possess or visibly display a firearm during the commission of or attempt to commit a violent crime to wit: the defendant did possess a FN 5.7 x 28mm pistol, bearing serial number 386274257, during the commission of and in furtherance of a cocaine trafficking conspiracy, a heroin trafficking conspiracy, and a marijuana trafficking conspiracy, in violation of § 16-23-490, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such conduct arising out of or in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

### COUNT ELEVEN POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME S.C. Code Ann. § 16-23-490

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about

May 19, 2017, possess or visibly display a firearm during the commission of or attempt to commit a violent crime to wit: the defendant did possess a Taurus Defender revolver, bearing serial number EX502074, during the commission of and in furtherance of a cocaine trafficking conspiracy, a heroin trafficking conspiracy, and a marijuana trafficking conspiracy, in violation of § 16-23-490, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such conduct arising out of or in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

## COUNT TWELVE POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME S.C. Code Ann. § 16-23-490

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about May 19, 2017, possess or visibly display a firearm during the commission of or attempt to commit a violent crime to wit: the defendant did possess a .45 caliber Para Ordinance 1911 pistol, bearing serial number QH4683, during the commission of and in furtherance of a cocaine trafficking conspiracy, a heroin trafficking conspiracy, and a marijuana trafficking conspiracy, in violation of § 16-23-490, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such conduct arising out of or in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

### COUNT THIRTEEN POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME S.C. Code Ann. § 16-23-490

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about

May 19, 2017, possess or visibly display a firearm during the commission of or attempt to commit a violent crime to wit: the defendant did possess a .40 caliber Glock 23 pistol, bearing serial number TDB484, during the commission of and in furtherance of a cocaine trafficking conspiracy, a heroin trafficking conspiracy, and a marijuana trafficking conspiracy, in violation of § 16-23-490, Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law and such conduct arising out of or in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

# COUNT FOURTEEN POSSESSION WITH INTENT TO DISTRIBUTE MARIJUANA S.C. Code Ann. § 44-53-370(b)(2)

That JARVIS LAMONT BELLAMY (A/K/A "FACE") did in Horry County, on or about May 23, 2017, knowingly possess with intent to manufacture, distribute, dispense, or deliver a quantity of marijuana, a controlled substance under the provisions of § 44-53-110, et seq., Code of Laws of South Carolina (1976), as amended, such conduct not having been authorized by law; such conduct having significance in more than one county of this State; and such conduct arising out of and in connection with a crime involving narcotics, dangerous drugs, or controlled substances having transpired in more than one county of this State and having significance in more than one county of this State.

Against the peace and dignity of the State and contrary to the statute in such case made and provided.
