At a session of the State Grand Jury of South Carolina, convened in Columbia, South Carolina on April 19, 2018, the State Grand Jurors present upon their oath:

COUNT ONE CONSPIRACY S.C. Code Ann. §16-17-410

That DAVANTA TERRANCE JOHNSON (A/K/A "CHEDDAR"), TYREE DAYQUAN GEIGER, and NASIIR ALI SHAHEED DANIELS did in Lexington County on or about April 8, 2016 unlawfully, willfully, and knowingly unite, combine conspire, confederate, agree and have tacit understanding with one or more persons for the purpose of accomplishing an unlawful object; to wit: the attempted murder of one Enoch Palmer; all in violation of Section 16-17-410 of the South Carolina Code of Laws (1976), as amended, such conduct involving a criminal gang and a pattern of criminal gang activity.

COUNT TWO CONSPIRACY S.C. Code Ann. §16-17-410

That DAVANTA TERRANCE JOHNSON (A/K/A "CHEDDAR"), JAMAL TAEWON JOHNSON (A/K/A "MAL-B"), FAIQUAN DAEWOO SHYON SWINDELL (A/K/A "GUN PLAY"), TYREE DAYQUAN GEIGER, NASIIR ALI SHAHEED DANIELS, DAQUAN DARNELL HENDERSON (A/K/A "HUNCHO"), and DAIQUAN LAMONT BROOKS (A/K/A "QUAN STAKKS") did in Lexington County on or about April 8, 2016 unlawfully, willfully, and knowingly unite, combine conspire, confederate, agree and have tacit understanding with one or more persons for the purpose of accomplishing an unlawful object; to wit: the attempted murder of one Tevin Fountain and the discharging of a firearm into a dwelling; all in violation of Section 16-17-410 of the South Carolina Code of Laws (1976), as amended, such conduct involving a criminal gang and a pattern of criminal gang activity.

COUNT THREE ATTEMPTED MURDER S.C. Code Ann. §16-3-29

That DAIQUAN LAMONT BROOKS (A/K/A "QUAN STAKKS") and other persons whose names are known to the State Grand Jury did in Lexington County on or about April 8, 2016, with intent to kill and with malice aforethought, either expressed or implied, attempt to kill Tevin Fountain in violation of Section 16-3-29 of the South Carolina Code of Laws (1976), as amended, such conduct involving a criminal gang or a pattern of criminal gang activity.

COUNT FOUR DISCHARGING A FIREARM INTO A DWELLING S.C. Code Ann. §16-23-440

That DAIQUAN LAMONT BROOKS (A/K/A "QUAN STAKKS") and other persons whose names are known to the State Grand Jury did in Lexington County, on or about April 8, 2016, unlawfully discharge a firearm or cause a firearm to be discharged into a dwelling house or other building or enclosure regularly occupied by persons, to wit: 2121 Sandy Run Drive in the Gaston area of Lexington County, in violation of Section 16-23-440 of the South Carolina Code of Laws (1976), as amended, such conduct involving criminal gang activity or a pattern of criminal gang activity.

Against the peace and dignity of the State and contrary to the statute in such case made and provided.
