



Between January 1, 2019 and January 31, 2019, the Defendant, Richard "Rick" Ansel Martin, did in Newberry County, commit the crime of Contributing to the Delinquency of a Minor in that the Defendant, who was over the age of eighteen (18) years of age, did knowingly and willfully encourage, aid or cause a minor, S.S. DOB: 9/16/2003, to violate the law, by providing her with alcohol to drink while less than 21 years of age, in violation of §16-17-490, Code of Laws of South Carolina, (1976, as amended).
