Human Trafficking Facts

- ► The crime of human trafficking does NOT require moving, traveling, or transporting a person across state or national borders.
- ➤ Human trafficking does NOT require kidnapping or physical force. More instances involve psychological means such as manipulation and threats by traffickers.
- ➤ Traffickers are NOT always strangers to their victims. People can be trafficked by romantic partners or family members.
- ▶ Victims of human trafficking are NOT always undocumented foreign nationals. Both US citizens and foreign nationals are vulnerable to the crime.
- ➤ Victims of human trafficking do NOT always readily accept or attempt to seek help. Factors may include fear of retribution from traffickers, including danger to their families as well as not self-identifying as a victim.
