The Silent Witness Story

In 2014, 39 South Carolinians were killed by their intimate partners. As citizens of this state, we have a responsibility to take a stand against this injustice. Therefore, in 1998 our state joined with more than 40 other states in a mission “to promote peace, healing and responsibility in adult relationships.”

During the 18th annual Silent Witness ceremony, wooden silhouettes represent the women and men who have died due to domestic violence in South Carolina in 2014. This year, there are 40 silhouettes; 29 are for the known female homicide victims, 10 are for the known male victims, and one represents those victims of whom we are unaware.

The South Carolina Attorney General’s Office, through the S.T.O.P. (Services, Training, Officers, and Prosecutors) Violence Against Women program hosts this annual remembrance. Other contributing citizens and organizations are acknowledged at the end of this book.

Dakota

Cook

21 years old

Aiken County

Terry Cook shot her husband, Dakota Cook, at their home on April 8, 2014. Police arrived to discover that Mr. Cook still had a pulse and EMS transported him to the emergency room. Shortly after, he was pronounced dead at the hospital. Mrs. Cook was charged with murder and possession of a weapon during the commission of a violent crime. She is currently awaiting trial.



*Stephen
Morris*

*63 years old
Aiken County*

Debra Morris shot her husband, Stephen Morris, at their home on September 1, 2014. Mrs. Morris later called law enforcement and stated that she had shot her husband. Police responded to the scene, where Mrs. Morris again told them she shot Mr. Morris and showed them the gun. Reports indicate the couple was having marital problems. Mrs. Morris was charged with murder and possession of a weapon during the commission of a violent crime. She is currently awaiting trial.

*Lacey
Parker*
32 years old
Aiken County

Todd Brown shot his former live-in girlfriend, Lacey Parker, at her home on March 19, 2014. Ms. Parker's neighbor heard the shots and called 911. Deputies responded and found Ms. Parker in the front yard. Mr. Brown was arrested and charged with burglary, possession of a weapon during the commission of a violent crime, and murder. He is currently awaiting trial.



*Teresa "Missi" Brant
Tomac
44 years old
Aiken County*

James Tomac shot his wife, Missi Tomac, at their home on November 22, 2014. After speaking with a family member, Mr. Tomac then turned the gun on himself and took his own life. The family member called 911 and police arrived to find Mr. and Mrs. Tomac unresponsive. EMS arrived shortly after and advised that both parties were deceased.

*Carol
Rogenski
39 years old
Anderson County*

Kyle Hand ran over his live-in girlfriend, Carol Rogenski, with her car in the parking lot of a motel on July 8, 2014. The police and EMS arrived to find Ms. Rogenski unresponsive with head trauma. EMS transported her to the emergency room where she was pronounced deceased. Mr. Hand was charged with hit and run resulting in death, as well as grand larceny for stealing Ms. Rogenski's vehicle. He is currently awaiting trial.

*Jeanette
Chinn
80 years old
Beaufort County*

Brian Chinn shot his wife, Jeanette Chinn, at their home around April 10, 2014. He then turned the gun on himself and took his own life. The couple's son called a neighbor of his parents after not being able to make contact with them by phone for several days. When the neighbors went to the home, they were able to see the couple lying unresponsive in a bedroom. Deputies were called for assistance and arrived to find Mr. and Mrs. Chinn deceased. Mr. Chinn had shown signs of dementia a year prior to the shooting but had never made any reference to harming himself or his wife.

*Rebecca
Melton
55 years old
Beaufort County*

Nick Evangelista strangled his live-in girlfriend, Rebecca Melton, at their home on August 26, 2014. Police found Ms. Melton at the home several days later when Mr. Evangelista's workplace requested a welfare check after not hearing from him for a week. Mr. Evangelista fled to Florida, where he was arrested and charged with murder. He is currently awaiting trial.

*Tammy
Flowers*
36 years old
Berkeley County

Darryl Flowers shot his wife, Tammy Flowers, at their home on June 4, 2014. Mr. Flowers then fled the scene. When police arrived, they discovered Mrs. Flowers unresponsive and two of her nieces wounded by gunshots. Mr. Flowers was later arrested and charged with murder, two counts of attempted murder, two counts of kidnapping, and possession of a weapon during the commission of a violent crime. He is currently awaiting trial.

*Frances
Lawrence
60 years old
Berkeley County*

Lee Bradley stabbed his live-in girlfriend, Frances Lawrence, at their home on May 23, 2014. The next morning, Mr. Bradley called 911 to report that he had stabbed Ms. Lawrence during a fight and claimed he was trying to defend himself. Police arrived to find Ms. Lawrence deceased. There was a long history of domestic violence charges against Mr. Bradley in the relationship. He was arrested, charged with murder, and is currently awaiting trial.

Todd*
51 years old
Berkeley County

Janice Coleman stabbed her boyfriend, William Todd, at their home on December 21, 2014. A neighbor called 911 after Ms. Coleman told him she had killed Mr. Todd. Police arrived to discover Mr. Todd unresponsive. Ms. Coleman was arrested and charged with murder. She is currently awaiting trial.

*Augustina
Hernandez-Hernandez
32 years old
Charleston County*

Alberto Martinez-Villa stabbed his wife, Augustina Hernandez-Hernandez, on November 28, 2014. Mr. Martinez-Villa contacted police to file a missing persons report, but confessed to killing his wife after officers found Ms. Hernandez-Hernandez's body several days later in a public area. Mr. Martinez-Villa was arrested and charged with murder. He is currently awaiting trial.

*Rita
Pennington
59 years old
Cherokee County*

William Pennington shot his wife, Rita Pennington, at their home on June 21, 2014. Mr. Pennington then called 911 and claimed that he accidentally shot his wife while cleaning his gun. Police arrived to discover Mrs. Pennington deceased. According to family members, Mr. Pennington had a history of threatening to kill Mrs. Pennington and had pointed a gun at her in the past. Mr. Pennington was arrested and charged with murder. He is currently awaiting trial.

*Angie
Small*

*41 years old
Chester County*

Donald Small, Jr. shot his estranged wife, Angie Small, outside of her workplace on November 6, 2014. He then turned the gun on himself and took his own life. Mrs. Small's coworker saw them talking and then getting into a physical fight in the parking lot. As he went outside to break up the fight, he heard gunshots and went back inside to call 911. Police arrived to discover Mr. and Mrs. Small deceased.



*Julia
Richburg
57 years old
Clarendon County*

Johnnie Richburg shot his wife, Julia Richburg, at their home on August 9, 2014. Mr. Richburg then went to the county detention center to report that he killed his wife. Police responded to their home to discover Mrs. Richburg deceased. Mr. Richburg was arrested and charged with murder, possession of a weapon during the commission of a violent crime, and possession of a firearm and ammunition by a convicted felon. He is currently awaiting trial.

*Tiana
Mendez
30 years old
Dillon County*

Miguel Mendez shot his wife, Tiana Mendez, and her friend at their home on November 15, 2014. Mr. Mendez then turned the gun on himself and took his own life. Upon entering the home, Mrs. Mendez's niece found her aunt on the bed and called 911. Police arrived to discover all three persons deceased.



*Stephanie
Taylor*

*52 years old
Dorchester County*

Glenn Taylor shot his wife, Stephanie Taylor, at their home on December 2, 2014. Mr. Taylor then called 911 to report the shooting. Law enforcement arrived to discover Mrs. Taylor unresponsive. Mr. Taylor later confessed to the killing but claimed it was self-defense. His statements were found inconsistent with the evidence and he was arrested and charged with murder and possession of a weapon during the commission of a violent crime. He is currently awaiting trial.

*Travis
Francis
25 years old
Florence County*

Shanasia Garland shot her live-in boyfriend, Travis Francis, at their home on December 4, 2014. Ms. Garland called 911 to report that Mr. Francis had been shot by an unknown assailant. Police arrived to discover Mr. Francis unresponsive. Ms. Garland confessed later that day to shooting her boyfriend during a fight. She was arrested and charged with murder and possession of a weapon during the commission of a violent crime. She is currently awaiting trial.

*Fermiond
Smith
60 years old
Georgetown County*

Sonia Smith shot Fermiond Smith at their home on August 8, 2014. Mrs. Smith then called 911 to report that she had shot her husband during a fight. Police arrived to discover Mr. Smith unresponsive. Neighbors stated that the couple had a history of fighting. Mrs. Smith was arrested and charged with murder. She is currently awaiting trial.

*Lawrence
Bress
35 years old
Greenville County*

Ramona Gilmore stabbed her husband, Lawrence Bress, at their home on July 19, 2014. A neighbor called 911 to report the incident. Law enforcement arrived to discover Mr. Bress severely injured, and he became unresponsive before EMS arrived. Ms. Gilmore was arrested and charged with murder and possession of a weapon during the commission of a violent crime. She is currently awaiting trial.

*Janice
Hackett*
42 years old
Greenville County

Sylvester King stabbed his former live-in girlfriend, Janice Hackett, at her home on March 16, 2014. Mr. King then fled the scene. Ms. Hackett's minor son discovered his mother when he returned home from an errand and called 911. Law enforcement arrived to find Ms. Hackett deceased. Mr. King was later arrested and charged with murder. He is currently awaiting trial.

*Kimberly
Sledge
51 years old
Greenville County*

John Sledge shot his wife, Kimberly Sledge, at their home on January 29, 2014. While Mr. Sledge fled the scene, the couple's minor son called 911. Officers arrived to discover Mrs. Sledge unresponsive. Mr. Sledge was soon located, arrested, and charged with murder and possession of a weapon during the commission of a violent crime. He is currently awaiting trial.

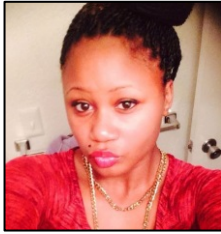
*Jennifer
Youngblood
25 years old
Greenville County*

David Thompson stabbed his former live-in girlfriend, Jennifer Youngblood, at her home on May 23, 2014. Ms. Youngblood's mother called 911 after returning home and discovering Ms. Youngblood unresponsive. Mr. Thompson was later arrested and charged with murder and possession of a weapon during the commission of a violent crime. He is currently awaiting trial.



*Eboni
Drayton
21 years old
Horry County*

John Scott killed Eboni Drayton, the mother of his child, at her home with blunt force on August 29, 2014. When he called his mother and stated that he thought he had killed Ms. Drayton, his mother called 911. Police arrived to discover Ms. Drayton deceased. Mr. Scott was arrested and charged with murder. He is currently awaiting trial.



*Quatavia
Robinson
18 years old
Lancaster County*

Keishawn McManus shot Quatavia Robinson at their home on December 23, 2014. Mr. McManus then called 911 to report that his live-in girlfriend had committed suicide. Law enforcement arrived to discover Ms. Robinson unresponsive. Mr. McManus fled the area after speaking with officers. It was later determined that Ms. Robinson did not commit suicide. Warrants have been issued for Mr. McManus's arrest for murder and possession of a weapon during the commission of a violent crime. He has not been arrested due to his unknown whereabouts.



*Susan
Wilkes*
59 years old
Lexington County

Marion Wilkes stabbed his wife, Susan Wilkes, around June 9, 2014. The couple's son, Joseph Wilkes, was an accomplice. Mr. Wilkes then called 911 to report his wife as a missing person. Police found Mrs. Wilkes' body several days later in Little Mountain, South Carolina. Mr. Wilkes and Joseph Wilkes were arrested and charged with murder. Mr. Wilkes has since confessed to murdering his wife. Both are currently awaiting trial.



*Samuel
Simmons*
24 years old
Orangeburg County

Courtney Price stabbed Samuel Simmons, the father of her child, at her home on September 27, 2014. Ms. Price then called 911 to report that she had stabbed Mr. Simmons. Police arrived to discover him severely injured. Mr. Simmons was unresponsive by the time EMS arrived. Ms. Price was arrested and charged with murder. She is currently awaiting trial.

*Eva
Haynie
51 years old
Pickens County*

Richard Haynie shot his wife, Eva Haynie, while at their vacation home in North Carolina on November 24, 2014. Mr. Haynie then turned the gun on himself and took his own life. Friends stated that the couple had no history of violence but that Mr. Haynie had recently lost his job and was exhibiting signs of depression. Police found the couple deceased during a welfare check requested by a coworker after Mrs. Haynie did not show up for work.



*Shane
Williams
38 years old
Pickens County*

Crystal Williams paid a friend to shoot Shane Williams at their home on January 26, 2014. Mrs. Williams called 911 to report that her husband had been shot while she was asleep. Police arrived to discover Mr. Williams unresponsive. After an investigation, both Mrs. Williams and her accomplice were arrested. Mrs. Williams was charged with murder and conspiracy to commit murder. She pled guilty to both charges and was sentenced to life in prison without parole.

*Akawandlis
Byrd
28 years old
Richland County*

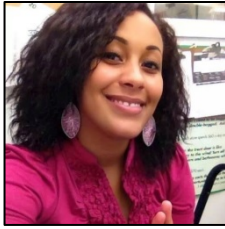
John Corbett shot Akawandlis Byrd, his former live-in girlfriend, at her home on September 3, 2014. Mr. Corbett also shot another man and attempted to shoot another woman who were residing in the house. The woman called 911 to report the shooting. Law enforcement arrived to discover Ms. Byrd in serious condition; she died shortly after. The following day Mr. Corbett turned himself in to police. He was charged with murder and two counts of attempted murder. He is currently awaiting trial.

*Diamoney
Greene
20 years old
Richland County*

Brandon Early shot his live-in girlfriend, Diamoney Greene, at their home around November 11, 2014. Mr. Early then turned the gun on himself and took his own life. Their roommate later returned to the apartment and called 911 to report that he had not seen or heard from Mr. Early or his girlfriend for several days. Police arrived to discover the couple deceased.

*Kia
Miller
28 years old
Richland County*

Sheddric Miller shot his wife, Kia Miller, at their home in early January 2014. Mr. Miller also shot and killed the couple's two children before turning the gun on himself and taking his own life. Mr. Miller's mother alerted law enforcement when she went to the home after not hearing from the family for several days. Police arrived to find Mrs. Miller and her family deceased.



*Aja
Robinson
23 years old
Richland County*

Jeremy Mickens shot Aja Robinson, his live-in girlfriend, in a parking lot of a local business on June 13, 2014. He then turned the gun on himself and took his own life. Police in the area were flagged down by a witness who heard the gunshots. Upon arrival, officers found Mr. Mickens and Ms. Robinson unresponsive. The coroner's office pronounced them deceased at the scene.

*Theresa
Steward
51 years old
Richland County*

Timotheus Hemingway killed Theresa Steward, his former live-in girlfriend, at her home with blunt force trauma to the head on April 26, 2014. Mr. Hemingway called his sister and stated he and Ms. Steward were involved in another fight and he believed he may have hurt her. His sister then called 911 to request a welfare check. After searching the surrounding area, officers found Ms. Steward's body. Mr. Hemingway was arrested and charged with murder. He is currently awaiting trial.

*Lisa
James
44 years old
Spartanburg County*

Rex Scott shot his wife, Lisa James, in their home on November 18, 2014. A video camera set up in the residence revealed that the couple was involved in an argument over money. Mr. Scott, who was a retired Spartanburg County sheriff's deputy, shot Ms. James, then turned the gun on himself and took his own life. Deputies responding to the scene when a family member requested a welfare check found Mr. Scott and Ms. James deceased.

*Mitzi
Larson
42 years old
Spartanburg County*

Michael Larson shot Mitzi Larson in their home on May 17, 2014. Mr. Larson then called 911 to report that he had killed his wife. Responding deputies found Mrs. Larson deceased in the home. The couple's sons told deputies that Mr. and Mrs. Larson had been in an argument earlier that day. Mr. Larson was arrested and charged with murder. He is currently awaiting trial.

*Mariann
O'Shields
55 years old
Spartanburg County*

Robert O'Shields shot his wife, Mariann O'Shields, on the side of a road on April 30, 2014 when she was leaving a domestic violence shelter where she was staying with their child. Mr. O'Shields then fled the scene. A witness called 911 and deputies arrived to find Mrs. O'Shields responsive. EMS transported her to the hospital, where she later died as a result of her injuries. Mr. O'Shields was arrested and charged with murder, possession of a weapon during the commission of a violent crime, and violation of an order of protection. He is currently awaiting trial.



*Mallory
Richardson
22 years old
Sumter County*

Helen Wells stabbed her live-in boyfriend, Mallory Richardson, at their home on July 26, 2014. Ms. Wells then threw the knife in the front yard and called 911. Deputies arrived on the scene to find Mr. Richardson unresponsive. EMS attempted to revive Mr. Richardson but was unsuccessful. Ms. Wells was arrested and charged with murder. She is currently awaiting trial.

*Charles
Burroughs
39 years old
Williamsburg County*

Donna Hemmans shot Charles Burroughs on July 11, 2014. Ms. Hemmans later called 911 to report that she had discovered her live-in boyfriend shot by an unknown assailant when she returned to their home after they had an argument that evening. Deputies arrived to find Mr. Burroughs unresponsive. Ms. Hemmans' statements were found to be inconsistent with the evidence and she was arrested and charged with murder and possession of a weapon during the commission of a violent crime. Ms. Hemmans is currently awaiting trial.

*Barbara
Gregory
71 years old
York County*

Ronald Gregory shot his wife, Barbara Gregory, and their minor granddaughter at their home on March 21, 2014. Mr. Gregory later called 911 and requested law enforcement to come to the home. Mr. Gregory then shot himself twice. Deputies arrived to discover Mrs. Gregory and her granddaughter deceased and Mr. Gregory injured. He was arrested and charged with two counts of murder and possession of a weapon during the commission of a violent crime. He pled guilty but mentally ill to all charges and was sentenced to life in prison without parole for murder and 5 years for possession of a weapon.
