Dear Mr. Spradley:

You have asked the opinion of this Office on whether a member of the Commission of Public Works for the Town of Batesburg concurrently may serve as the volunteer fire chief of the Town.

Article XVII, § 1A of the South Carolina Constitution provides that '... no person shall hold two offices of honor and profit at the same time.' For this provision to be violated, a person concurrently must hold two offices which have duties involving an exercise of some part of the sovereign power of the State. <u>Sanders v. Belue</u>, 78 S.C. 171 (1907).

Previous opinions by this Office have concluded that Commissioners of Public Works are public officers within the meaning of Article XVII, § 1A. Opinion to Mayor Zimmie Mason, Town of City View, dated August 4, 1969; opinion to Mayor Cody Owns, Town of Whitmire, dated May 2, 1974 [copies enclosed]. <u>Also see</u> Sections 5-13-210 to 5-13-270, Code of Laws of South Carolina, 1976.

The provision of fire departments for municipalities is contained in Chapter 25, Title 5 of the Code. Although municipalities with populations less than 5,000, like Batesburg, are authorized to equip and control a fire department, the statutory provisions establishing the position of chief of a municipal fire department and setting forth his duties are not applicable to such municipalities. Sections 5-25-10, 5-25-20, 5-25-110. Thus, it appears that the position of volunteer fire chief of the municipality of Batesburg is not a public office within the meaning of Article XVII, § 1A. Rather, it appears to be a position involving the occasional gratuitous rendition of fire protection services. See, Sanders v. Belue, supra; Opinion to Representative David S. Taylor, dated December 17, 1969 (copy enclosed).¹

In addition to the above, my review of Title 5 of the Code has not revealed any provisions prohibiting a member of the Commission of Public Works from serving as the volunteer fire chief of a fire department in a municipality with less than 5,000 persons.

Based on the foregoing, it is the opinion of this Office that a member of the Commission of Public Works for the municipality of Batesburg may serve concurrently as the volunteer fire chief of the municipal fire department. Sincerely,
