Gentlemen:

With reference to your request for an Approval Letter concerning a coin-operated device identified as 'Memorial Token Vendor', it is necessary to point out that the Attorney General does not render advice as to the legality of private persons conduct.

However, you should be alerted to Title 5, Chapter 7 of the Code of Laws of South Carolina (1962) which makes unlawful vending or slot machines unless constructed to have no element of chance and to give a fair return in value for each coin deposited. S.C. Code Ann. § 5-621. Sincerely,
